2. That this Tender is made by the Tenderer without any connection, knowledge, comparison of figures or arrangement with any other person or persons making a Tender for the same work, and is in all respects fair and without collusion or fraud.

I (We), having carefully studied the Contract Documents agree:

1. That this Tender is irrevocable and may not be withdrawn by the bidder, subject to the conditions of the Bid Documents pertaining to the withdrawal of bids, and is open for acceptance by the Owner for the bid acceptance period.
2. That if the Tender is accepted, the Tenderer agrees to furnish bonds as specified in the Instructions to Bidders and to execute the agreements and bonds in triplicate within seven (7) Working Days after notification of acceptance of this Tender by the Owner.
3. That in the event or failure to do so, the Tenderer agrees that the Bid Bond made with this Tender shall be forfeited to the Owner and that the Owner may accept any other Tender or call for new Tenders.
4. Bid Bond - We enclose herewith a Bid Bond in the value of not less than 10% of our stipulated price as outlined below. It is understood that the Bid Bond shall be valid for the bid acceptance period, the bidder will provide a Performance Bond and a Labour and Materials Payment Bond in the specified amount.

 1. Execute the Canadian Standard Construction Document CCDC 2, 2008, as amended by the Supplementary Conditions.

Furnish a Performance Bond in the amount equal to One hundred percent (100%) and a Labour and Material Bond in the amount equal to fifty (50%) of the amount of the Contract, in the form described in the Specifications. Note: Maintenance Security to be covered by the Performance Bond or Maintenance Security as a standalone Bond
 3. Furnish a general analysis of the Contract sum, the total aggregate the amount of our Contract sum.
 4. Complete the entire work included in the Contract as specified in Instructions to Bidders.
