QUESTIONS AND ANSWERS

- 2.1 Question: Who is the Boards Controls Contractor for this school?
Answer: *The board contractor is Johnson Control.*
- 2.2 Question: The Cash Allowances shown on the Bid Form are different from the Cash Allowances shown in Spec Section 01 21 13 Item 1.3.10. Can you please confirm which is correct?
Answer: *The amounts for cash Allowances will be updated in the next Addendum.*
- 2.3 Question: Can you please confirm the bid irrevocability period for this tender? We noticed that under the Agreement to Bond section of the Bid Document it indicates that Bonds shall be irrevocable for 30 days, however, in the Key Dates table it indicates that the irrevocability period is 90 days.
Answer: *The irrevocability period is 90 days*
- 2.4 Question: Does this project require builder risk insurance and warp up?
Answer: *Yes, \$5 million*
- 2.5 Question: Is there any prequalified or preferred trade for this job?
Answer: *No there is not.*
- 2.6 Question: Please provide landscape drawings.
Answer: *There are not landscape drawings. Refer to architectural site plan. Reinstate all disturbed landscape area with sod on 100mm topsoil.*
- 2.7 Question: In Addendum #1 we are asked to sign a form that states that we have received the addendum. In bids and tenders, Section 4 requires us to check off the addendums we have reviewed. Is it still necessary to include that form included in the addendum with our bid submission and if so, where would be insert the signed addendums?
Answer: *No, it is not necessary to include this form, checking off that the addendum was received in section 4 is acceptable.*
